The Order will be effective at certain times from 12:01 AM on 31st July 2023 until 11:59 PM on 30th November 2023 or when any further order made comes into effect whichever is the sooner. The prohibitions will apply only during such times and to such extent as shall from time to time be indicated by traffic signs.

4. The prohibitions will not apply in respect of:

- (1) any vehicle being used for the purposes of those works or for fire brigade, ambulance or police purposes;
 - (2) anything done with the permission or at the direction of a police constable in uniform or a person authorised by Transport for London.
5. The A24 GLA Road (High Street Colliers Wood, London Boroughs of Merton) (Temporary Prohibition of Stopping) Order 2021 is hereby repealed
