

# Transport for London Notice

## ROAD TRAFFIC REGULATION ACT 1984

### THE A4 AND A3220 GLA ROADS (ROYAL BOROUGH OF KENSINGTON AND CHELSEA AND CITY OF WESTMINSTER) (TEMPORARY PROHIBITION OF TRAFFIC AND STOPPING) ORDER 2023

1. Transport for London in consultation with the Royal Borough of Kensington and Chelsea hereby gives notice that it intends to make the above named Traffic Order under section 14(1) of the Road Traffic Regulation Act 1984 for the purpose specified in paragraph 2. The effect of the Order is summarised in paragraph 3.
2. The purpose of the Order is to enable highway lining and signage works to take place on the A4 Knightsbridge/ Brompton Road/ Thurloe Place/ Cromwell Road and Cromwell Gardens, the A3220 Holland Road, Addison Crescent, Addison Road, Warwick Gardens, Pembroke Road, Earls Court Road, Warwick Road, Finborough Road, Redcliffe Gardens, Gunter Grove, Ashburnham Road, Cremorne Road and Edith Grove.
3. The effect of the Order will be to prohibit any vehicle from:
  - (1) entering, exiting or stopping on the A4 Knightsbridge/ Brompton Road/ Thurloe Place/ Cromwell Road and Cromwell Gardens between its junctions with Hyde Park Corner and Earls Court Road;
  - (2) entering, exiting or stopping on the A3220 Holland Road, Addison Crescent, Addison Road, Warwick Gardens, Pembroke Road, Earls Court Road, Warwick Road, Finborough Road, Redcliffe Gardens, Gunter Grove, Ashburnham Road, Cremorne Road and Edith Grove between its junctions with Cremorne Road and Holland Park Avenue;

The Order will also permit:

- (3) all vehicles to use the eastbound and westbound bus lanes on the A4 Knightsbridge/ Brompton Road/ Thurloe Place/ Cromwell Road and Cromwell Gardens between its junctions with Hyde Park Corner and Earls Court Road;
- (4) all vehicles to use the northbound and southbound bus lanes on the A3220 Holland Road, Addison Crescent, Addison Road, Warwick Gardens, Pembroke Road, Earls Court Road, Warwick Road, Finborough Road, Redcliffe Gardens, Gunter Grove, Ashburnham Road, Cremorne Road and Edith Grove between its junctions with Cremorne Road and Holland Park Avenue;

Works will be phased such that some restrictions will apply only at certain times.

The Order will be effective at certain times from 12:01 AM on 4th September 2023 until 5:00 AM on 21st March 2024 or when the works have been completed whichever is the sooner. The prohibitions will apply only during such times and to such extent as shall from time to time be indicated by traffic signs.

4. The prohibitions will not apply in respect of:
  - (1) any vehicle being used for the purposes of those works or for fire brigade, ambulance or police purposes;
  - (2) anything done with the permission or at the direction of a police constable in uniform or a person authorised by Transport for London.
5. At such times as the prohibitions are in force alternative routes will be indicated by traffic signs.
