

The Council of the London Borough of Lewisham proposes to make the above Traffic Regulation Orders under the Road Traffic Regulation Act 1984 (as amended).

1. The effect of these proposals is as follows:

PTO 1024a The effect of the above orders will be to introduce the following restrictions to facilitate the introduction of a Residents Parking Permit scheme Monday to Friday between 9am and 5pm.

A. No waiting at any time

Gosterwood Street – a) at the junction between and **Alverton Street**; b) at the northern end; c) across entrance to Box Tree Ho, the entrance to garages at Hodan's Day Care Nursery and outside No 130. **Barnes Terrace** – on the north side including the southeast closed end. **Grove Street** – a) at entrance to Leeway; b) on the southwest side across entrances to North Ho and Camden Ho; c) on the northeast side at junction with Barnes Terrace; opposite North Ho; across the entrances to Nos 88 – 98, d) on the west side across entrance to Fulcher Ho, Grafton Ho, Hurston Ho, e) across the entrance to Sayes Court. **Alverton Street** – a) at junction with Etta Street; b) at the junction with Rolt Street; c) at entrance to Akintaro Ho. **Blackhorse Road** – a) on the southeast side across entrance to car park opposite unit 8 and across the entrance to allotment gardens, b) on the northwest side extent existing across entrance to Deptford Trading Estate. **Sayes Court Street** – a) on the north side between Grove St and Dacca St, b) on the south side across entrance to post office and corner adjacent to No 313 c) across access to Chester Ho. **Dacca Street** – on both side from the junction with Sayes Court St and Prince St including the area around the green. **Prince Street** – on both sides in various locations east of the junction with Czar St. **Rolt Street** – on the east side at entrance to Eder Court. **Abinger Grove** – a) extend exiting south of Poppy Crt, b) either side of Kerry Path, c) various additional entrance protection with extensions outside No 6 and No 9-10 Kittiwake Court. **Staunton Street** – on both sides in various locations including the access to Wardalls Court. **Czar Street** – on the west side. **New King Street** – a) on the east side, b) on the west side either side of Czar Street. **Childers Street** – on the south side from the junction with Abinger Grove to the east end including turning area. **Kerry Path** – both sides for entire length. **Arklow Road** – at the entrance to Assembly House. **Trim Street** and the junction with Kerry Road. **Kerry Road** – on both sides either side on the junction with Trim Street. **Trim Street** – a) on the eastern and western side outside Nos 12 and Luli Court, b) on the south side between the southern arm and Kerry Street. **Clyde Street** – a) either side of Diana Close, b) on the east side across entrance to Evelyn Hall, c) on the west side across the entrance to Dolphin Tower, d) on the west side between Dolphin Tower and the southern closed end. e) on the southern side across the entrances to Walnut Close (including western turning area), Larch Close and Beech Close. **Grinling Place** – a) on the west side, b) either side of eastern arm of Grinling Place c) on the south side including the eastern turning area. **Hyde Street** – on the west side and the south side of the northern arm. **Hamilton Street** – at the junction with Hyde Street. **Edward Street** – a) on both sides across the junctions with Amwesahm Vale, Trim Street, Payne Street, b) across residential accesses on north side, c) on the west side between Payne Street and Edward Place. **Amersham Vale** – a) opposite Napier Close, b) outside police station, c) opposite Amersham Grove, d) either side of Douglas Way, e) on both sides north of red route at New Cross Road. **Amersham Grove** – a) east side south of Edward Street, b) on both sides outside Nos 22-28. **Edward Place** – a) on the south side, b) on the north side at eastern end c) on both sides between Ibis Court and Payne Street. **Adolphus Street** – a) on the east side at entrance to Maple House, b) on the west side at entrance to Nos 1-16, c) on west side across access to Stanhope House. **Octavius Street** – on the east side including the southern turning area. **Idonia Street** – a) across entrance to Camelia House, b) across entrance to Sandpiper Court. **Creekside** – a) on both sides at the junction with Barthon Street b) on the east side across access to Kent Wharf, c) on the east side in layby north of Bowhouse Court, d) on the west side outside Holden House and Wilshaw House. **Royal Naval Place** – on both side at the west end to Hereford Place. **Hereford Place** – on both sides other than pay for parking bay. **Mornington Road** – on both sides at various locations other than proposed bays including junctions with Glenville Grove. **Glenville Grove** – on both sides east of Mornington Road including all arms other than proposed bays. **Baildon Street** – a) on the north and east sides outside No 12, and outside No 14 to the northern end including the turning area, b) on the southern and western side. **Speedwell Street** – across to rear access to Shaftesbury Place. **Comet Street** – a) on the south side between Watson Street and Speedwell Street, b) on the north side between Speedwell Street and Comet Place. **Comet Place** – on both sides other than where bays are proposed. **Reginald Square** – a) outside Nos 1-8 Covell Court, b) across access to Lady Florence Courtyard, c) on both sides at the entrance to Admiralty Close d) across access to rear of No 24 Deptford High Street.

No waiting Monday to Friday 9am – 5pm

Blackhorse Road – a) on the northwest side across both vehicle entrances and the goods entrance to Blackhorse Business Park, b) on the southeast side outside the rear of No 112-114, and Nos 100 – 88 Gosterwood Street. **Grove Street** – a) on the northeast side outside Nos 100 – 108; b) on the east side outside No 18 – 30 c) on the west side across the entrance to Trinity Social Club. **Barnes Terrace** – on the south side alongside No 86 Grove Street. **Alverton Street** – across entrance to Citrus Ho and outside No 1 – 3. **Etta Street** – on east side outside access to Clyde Early Childhood Centre. **Dacca Street** – outside No 60. **Rolt Street** – on the east side across the entrance to No 31 and outside Nos 33 – 47. **Dorking Close** – on both sides west of the junction with Violet Close. **Staunton Street** – outside No 41-47. **Czar Street** – on the south side outside No 1-59 and the refuse store outside No 40-42. **New King Street** – on the west side including the junction with Czar Street. **Arklow Road** – on the northeast side across all residential driveways. **Clyde Street** – a) across residential accesses on the south side, b) on the north side across the access to The Drakes and Indo Chinese Community Centre. **Amersham Grove** – a) on the south side across gap between No 36-36a, b) on the west side outside Nos 1-5 Windsor Cottages. **Creekside** – on both sides covering vehicular accesses. **Stanley Street** – across residential accesses for No 15-21. **Royal Naval Place** – on the north side over access to Allotments. **Baildon Street** – on the north side outside Nos 4-12. **Comet Street** – at the rear access to No 12 Watsons Street. **Watsons Street** – across accesses to north of No 20 and outside No 18. **Edward Street** – on the north side across access to No 80a. **Alverton Street** – across the access to Akintaro House. **Trim Street** – across residential accesses between Nos 13-18 and Nos 2-8.

B. Resident permit holders only

Gosterwood Street – on both sides in various locations between the northern end and Childers Street. **Blackhorse Road** – on the southeast side either side of entrance to car park opposite unit 8. **Grove Street** – on both side at various locations between Leeway and Evelyn Street. **Barnes Terrace** – a) on the north side alongside No 88 Grove St, b) outside No 12 Barnes Terrace. **Etta Street** – on both sides in various locations between Alverton Street and Childers Street. **Alverton Street** – on the north side in various locations between Gosterwood Street and Rolt Street. **Sayes Court Street** – on the south and west and east side between Grove St and Prince St. **Dacca Street** – on both side from the junction with Sayes Court St and Prince St including the area around the green. **Prince Street** – on the north side between Sayes Court St and Dacca St. **Rolt Street** – on both sides in various locations between Alverton St and Childers St. **Dorking Close** – on the south side west of Violet Close. **Staunton Street** – on both side in various locations. **Czar Street** – on both sides between Prince Stand New King St. **Childers Street** – on the north side east of Abinger Grove. **Arklow Road** – on the northeast side between Abinger Grove and Trim Street. **Clyde Street** – a) in various locations on the southern arm, b) on the east side south of Diana Close, c) on the west side outside Kingfisher Square. **Grinling Place** – on the northern side. **Hamilton Street** – on the south side. **Hyde Street** – a) on the east side, b) at the western end. **Amersham Vale** – on both sides at various locations. **Adolphus Street** – on both sides at various locations. **Rochdale Way** – on the north side. **Octavius Street** – on both sides at various locations. **Idonia Street** – a) on the west side at various locations, b) on the east side south of Edward Place. **Creekside** – on both side at various locations between Berthon Street and the entrance to Holden House. **Bronze Street** – on the south side. **Douglas Way** – on the north side. **Stanley Street** – a) on the east side between Douglas Way and No15, b) on the north side outside the

Mornington Centre. **Mornington Road** – on the western side at various locations. **Glenville Grove** – on both sides of all arms at various locations. **Baildon Street** – in layby between Nos 12 and 14. **Speedwell Street** – in available kerb space on the east and south sides. **Comet Street** – a) on the south side between Watson Street and Speedwell Street, b) on the north side between Speedwell Street and Comet Place. **Watsons Street** – on the east side outside Nos 18-20 Elgar Close. **Reginald Square** – on both sides to include laybys at various locations. **Edward Street** – on the south side outside No 80a. **Trim Street** – on the west side either side of the entrance to Luli Court, b) on the south side outside Luli Court and New Deptford Green, c) on the north side opposite Nos 9-11.

C. Business permit only

Blackhorse Road – various locations on the northwest side between Evelyn Street and railway arches. **Edward Place** – on the north side. **Payne Street** – on the north side between Edward Place and Edward Street. **Comet Place** – on the east side at various locations outside Nos 23 Elgar Close and 56 Vaughan Williams Close. **Reginald Close** – on the west side outside the rear of Nos 34-40 Deptford High Street with access gap. **Edward Street** – on the north side outside No 80a.

D. Permit holders only

Childers Street – on both sides in various locations between Gosterwood Street and Abinger Grove.

Etta Street – on the northwest side opposite Nos 3 – 17. **Alverton Street** – on the south side in various locations between Gosterwood Street and the southeast end. **Sayes Court Street** – on the west side outside No 319. **Prince Street** – on the south side between Dacca Street and New King St. **Dorking Close** – opposite Violet Close. **Abinger Grove** – on both sides in various locations between Evelyn St and opposite Poppy Crt. **Childers Street** – on the north side west of Royal Close. **Arklow Road** – on the southwest side between Assembly House and Trim Street. **Amersham Vale** – a) on the east side north of police station, b) on west side between Amersham Grove and Royal Naval Place. **Amersham Grove** – on the north side opposite Nos 30- 44. **Adolphus Street** – on the east side outside Stanhope House. **Rochdale Way** – on the south side. **Idonia Street** – on the east side. **Creekside** – a) on the west side between Berthon Street and Bronze Street. b) outside Creekside Centre and Flounder House. **Douglas Way** – on the south side. **Mornington Road** – a) on the east side north of Glenville Grove, b) on the west side south of Glenville Grove. **Comet Street** – on the north side east of Watson Street. **Watsons Street** – on the east side south of Albion House.

G. Electric vehicle only

Grove Street – opposite Hurlleston Ho and outside Camden Ho. **Etta Street** – opposite No 21. **Gosterwood Street** – on the southeast side opposite No20. **Sayes Court Street** – outside No 315/317. **Childers Street** – a) opposite No 14, b) opposite The Arches, c) opposite Poppy Court. **Abinger Grove** – outside Linden Ho. **Childers Street** on the north side outside opposite Poppy Court. **Clyde Street** – opposite Evelyn Hall. **Amersham Vale** - on east side outside Waldron Health Centre, b) on the west side at junction with Edward Street. **Arklow Road** – on the east side north of Trim Street. **Edward Place** – on the north side at the eastern end of new business bays. **Aldolphus Street** – on the east side outside No 19-24 Stanhope House. **Octavius Street** – on the west side south of Rochdale Way. **Creekside** – on the east side opposite Wilshaw House. **Stanley Street** – on the east side at the southern end. **Douglas Way** – on the south side west of Stanley Street. **Royal Naval Place** – on the north side at the west end. **Comet Street** – on the south side east of Speedwell Street. **Watsons Street** – on the east side outside Albion House. **Reginald Square** – on the south side outside Nos7-14 Admiralty Close. **Blackhorse Road** – opposite No 111. **Edward Street** – on the south side west of Payne Street. **Alverton Street** – opposite the access to Akintaro House.

H. Car club

Grove Street – opposite Hurlleston Ho and outside Camden Ho. **Etta Street** – opposite No 23. **Gosterwood Street** – on the southeast side opposite No 22. **Sayes Court Street** – outside No 317. **Childers Street** opposite No 16. **Abinger Grove** – outside Linden Ho. **Childers Street** a) opposite No 14, b) opposite The Arches, c) opposite Poppy Court. **Arklow Road** – on the southwest side opposite Safa House. **Clyde Street** – opposite Evelyn Hall. **Amersham Vale** – a) on east side outside Waldron Health Centre, b) on the west side at junction with Edward Street. **Amersham Grove** – on the north side opposite gap between No 36-36a. end of new business bays. **Aldolphus Street** – on the east side outside No 19-24 Stanhope House. **Octavius Street** – on the westside along No 32 Rochdale Way. **Idonia Street** – on the west side south of entrance to Camelia House. **Creekside** – a) on the east side opposite Wilshaw House, b) on the east side outside No 1-14 Portside Court. **Douglas Way** – on the south side west of Stanley Street. **Royal Naval Place** – on the north side at the west end. **Mornington Road** – on the east side north of Glenville Grove. **Comet Street** – on the south side east of Speedwell Street. **Watsons Street** – on the east side outside Albion House. **Reginald Square** – on the south side outside Nos7-14 Admiralty Close. **Blackhorse Road** – opposite No 111. **Edward Street** – on the south side west of Payne Street. **Alverton Street** – opposite the access to Akintaro House.

Blackhorse Road – on the southeast side opposite entrance to Blackhorse Business Park. **Grove Street** – opposite No 102, No 116 and on east side adjacent to No 30. **Etta Street** – opposite No 19. **Sayes Court Street** – outside No 315. **Dacca Street** – outside No 70. **Prince Street** – alongside no 19 Dacca Street. **Childers Street** – outside Ron Hoskin Hall. **Rolt Street** – opposite No 52. **Dorking Close** – opposite Violet Close. **Arklow Road** – on the southwest side opposite No 28. **Clyde Street** – outside the Indo Chinese Community Centre. **Amersham Vale** – a) on the west side at junction with Edward Street, b) at the junction with Amersham Grove. **Adolphus Street** – on the east side south of the entrance to Stanhope House. **Rochdale Way** – on the south side near Idonia Street. **Payne Street** – on the north side east of Edward Place. **Idonia Street** – on the west side south of entrance to Camelia House. **Creekside** – on the east side opposite Wilshaw House. **Douglas Street** – on the south side east of Amersham Vale. **Royal Naval Place** – on the north side at the east end. **Glenville Grove** – on the north side opposite Nos 1-3 The Edge. **Comet Street** – on the north side east of Watsons Street. **Watsons Street** – a) on the east side outside Albion House, b) outside No 14. **Reginald Square** – on the south side west of Lady Florence Courtyard.
