ARBUTHNOT ROAD, DRAKEFELL ROAD, GELLATLY ROAD, KITTO ROAD & PROPOSED INTRODUCTION OF DOUBLE YELLOW LINE “AT ANY TIME” WAITING RESTRICTIONS

The Lewisham (Charged-For Parking Places) (Amendment No. *) Order 202* The Lewisham (Free Parking Places, Loading Places and Waiting, Loading and Stopping Restrictions) (Amendment No. *) Order 202*

1. NOTICE IS HEREBY GIVEN that Lewisham Borough Council propose to make the above-mentioned Orders under sections 6, 45, 46, 49 and 124 of and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984, as amended.
2. The general effect of the Orders would be to introduce double yellow line “at any time” waiting restrictions in the following lengths of streets:
 - (a) **GELLATLY ROAD**
 - (i) the east side
 - at the junction with Arbuthnot Road (outside Nos. 7 to 11 and extending into Arbuthnot Road for approximately 10 metres on both sides);
 - outside Nos. 17 to 23 and Nos. 51 to 57;
 - at the junction with Kitto Road (adjacent to No. 1 Kitto Road extending into Kitto Road by approximately 10 metres on both sides);
 - (ii) the west side
 - outside Nos. 8 to 12, Nos. 18 to 24 , Nos. 52 to 58 and Nos 96 and 98 ;
 - across the gated junction of Kitto Road.
 - (b) **DRAKEFELL ROAD**
 - (i) the north side, outside No. 39 (to extend the existing double yellow line by 1.9 metres);
 - (ii) the south side
 - outside Nos. 64 (to extend the existing double yellow line by 2.3 metres);
 - outside Nos.70 (to extend the existing double yellow line by 2.4 metres).
3. Copies of the proposed Order, and other documents giving more detailed particulars of the Order, are available for inspection between 9 am and 5 pm on Monday to Friday at the reception of the Council’s office, Laurence House, 1 Catford Road, London, SE6 4RU. 4. Any objection or other representations relating to the proposed Order must be made in writing and all objections must specify the grounds on which they are made and must be emailed to trafficorders@lewisham.gov.uk or posted to Lewisham Transport Policy & Development, Laurence House, 1 Catford Road, London SE6 4RU, quoting reference “9420 Drakefell Road TMO” to arrive not later than 21 days from the date of publication of this notice. Any objection may be communicated to other persons who may be affected.
