**ROAD TRAFFIC REGULATION ACT 1984** 

## THE A501 GLA ROAD (OLD MARYLEBONE ROAD, CITY OF WESTMINSTER) (TEMPORARY PROHIBITION OF TRAFFIC AND STOPPING) ORDER 2023

- Transport for London in consultation with the City of Westminster hereby gives notice that it has made the above named Traffic Order
- under section 14(1) of the Road Traffic Regulation Act 1984 for the purpose specified in paragraph 2. The effect of the Order is summarised in paragraph 3.
- 2. The purpose of the Order is to enable footway and carriageway resurfacing works to take place on the A501 Old Marylebone Road.
- 3. The effect of the Order will be to prohibit any vehicle from: entering, exiting, proceeding or stopping on Old Marylebone Road (1) between its junctions with Edgware Road and Marylebone Road;
  - (2) turning left from Old Marylebone Road westbound into Edgware Road:
  - turning left from Harcourt Street into Old Marylebone Road; (3)entering Cabbell Street at its junction with Chapel Street,
  - residential access will be maintained;
  - (5) entering Transept Street at its junction with Chapel Street,
  - residential access will be maintained; (6) entering Homer Row at its junction with Crawford Place, residential
  - access will be maintained; entering Homer Street at its junction with Crawford Street, (7)
  - residential access will be maintained;
  - The Order will also: permit two-way operation in Cabbell Street between its junctions
  - with Old Marylebone Road and Chapel Street; permit two-way operation in Transept Street between its junctions with Old Marylebone Road and Chapel Street;
  - (10) permit two-way operation in Homer Row between its junctions with Old Marylebone Road and Crawford Place;
  - (11) permit two-way operation in Homer Street between its junctions with Old Marylebone Road and Crawford Street;
  - (12) permit two-way operation in Harcourt Street/ York Street between its junctions with Old Marylebone Road and Seymour Place. Works will be phased such that some restrictions will apply only at
  - certain times. The Order will be effective at certain times from 12:01 AM on the 30th October 2023 until 8:00 PM on the 30th March 2024 or when the works have been completed whichever is the sooner. The prohibitions

will apply only during such times and to such extent as shall from time

- to time be indicated by traffic signs. 4. The prohibitions will not apply in respect of: (I) any vehicle being used for the purposes of those works or for fire brigade, ambulance or police purposes;
  - anything done with the permission or at the direction of a police constable in uniform or a person authorised by Transport for
    - London.
- 5. At such times as the prohibitions are in force alternative routes will be indicated by traffic signs. For Old Marylebone Road south-eastbound via Marylebone Road westbound, A40 off-slip road to Edgware, Harrow Road westbound and Harrow Road eastbound to normal route of travel. For A501 from Edgware Road via Edgware Road northbound, Harrow Road westbound and Harrow Road eastbound and the A501 eastbound on-slip road to normal route of travel. For Edgware Road southbound via Sussex Gardens, Norfolk Place and Praed Street to normal route of travel. For Edgware Road southbound to A501 via Edgware Road southbound, George Street and Gloucester Place to normal route of
