- proposes to make The Lambeth (Free Parking Places, Loading Places and Waiting, Loading and Stopping Restrictions) (Amendment No. **) Order 202* and The Lambeth
- (Charged-For Parking Places) (Amendment No. **) Order 202* under the Road Traffic Regulation Act 1984 (as amended). 2. The general effect of the Orders would be to:-
- (1) remove disabled parking places from the locations specified in Schedule 1 to this Notice:
 - (2) introduce new "at any time" disabled parking places at the locations specified in Schedule 2 to this Notice; and,
 - 3) where the locations are in a controlled parking zone (CPZ); (a) to extend any parking space adjacent to the locations specified in Schedule 1 to replace the disabled parking place that would be removed, and (b) to reduce/remove any existing parking space at the locations specified in Schedule 2 to accommodate the new disabled parking places.
- 3. The Orders are necessary to remove certain disabled parking places where they are no longer required and to provide new disabled parking places where they are needed.
