1. NOTICE IS HEREBY GIVEN that Lewisham Borough Council on 6th of November made the above-mentioned Orders under sections 6, 45, 46, 49 and 124 of and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984, as amended. The Orders will come into force on 13th November 2023.

2. The general effect of the Orders will be to introduce double yellow line "at any time" waiting restrictions in the following lengths of streets: (a) GELLATLY ROAD

(i) the east side at the junction with Arbuthnot Road (outside Nos. 7 to 11 and extending into Arbuthnot Road for approximately 10 metres on both sides);

• outside Nos. 17 to 23 and Nos. 51 to 57; • at the junction with Kitto Road (adjacent to No. 1 Kitto Road extending into

Kitto Road by approximately 10 metres on both sides); (ii) the west side

outside Nos. 8 to 12, Nos. 18 to 24, Nos. 52 to 58 and Nos 96 and 98;

· across the gated junction of Kitto Road.

(b) DRAKEFELL ROAD (i) the north side, outside No. 39 (to extend the existing double yellow line by 1.9 metres);

(ii) the south side

• outside Nos. 64 (to extend the existing double yellow line by 2.3 metres);

• outside Nos.70 (to extend the existing double yellow line by 2.4 metres). 3. Copies of the made Orders, and other documents giving more detailed particulars of the

on the grounds that it or they are not within the powers conferred by the Road Traffic Regulation Act 1984, or that any requirement of that Act or of any instrument made under that Act had not been complied with, that person may, within 6 weeks from the date on
