THE A21 GLA ROAD (BROMLEY ROAD, LONDON BOROUGH OF LEWISHAM) (TEMPORARY PROHIBITION OF TRAFFIC AND STOPPING) ORDER 2023

1. Transport for London in consultation with the London Borough of Lewisham hereby gives notice that it has made the above named Traffic Order under section 14(1) of the Road Traffic Regulation Act 1984 for the purpose specified in paragraph 2. The effect of the Order is

- 2. The purpose of the Order is to enable highway and footway improvement works to take place on the A21 Bromley Road.
- improvement works to take place on the A21 Bromley Road 3. The effect of the Order will be to prohibit any vehicle from:
 - entering, exiting or proceeding in a southerly direction on Bromley Road between its junctions with Sangley Road and Bellingham Road;
 entering, exiting or proceeding in a southerly direction on Rushey
 - (2) entering, exiting or proceeding in a southerly direction on Rushey Green between its junctions with Catford Road and Sangley Road;
 - (3) stopping on Rushey Green between its junctions with Brown Hill Road and Sangley Road;
 - (4) stopping on Bromley Road between its junctions with Sangley Road and Bellingham Road;
 - (5) entering, exiting or proceeding in a northerly direction on Bromley Road between its junctions with Randlesdown Road and Sangley Road;
 - (6) entering or proceeding in a northerly direction on Bromley Road between its junctions with White Foot Lane and Randlesdown Road, local access will be maintained;
 - (7) stopping on Sangley Road between its junctions with Plassey Road and Bromley Road;

The Order will also:

- (8) permit all vehicles to use the northbound and southbound bus lanes on Bromley Road between its junctions with Sangley Road and Bellingham Road;
- (9) permit two-way operation on Canadian Avenue between its junction with Bromley Road and No.70 Canadian Avenue.
 Works will be phased such that some restrictions will apply only at

works will be phased such that some restrictions will apply only at certain times.

The Order will be effective at certain times between 6th November

2023 and 6th May 2024, every night 9:00 PM until 5:00 AM or when the works have been completed whichever is the sooner. The prohibitions will apply only during such times and to such extent as shall from time to time be indicated by traffic signs.

- 4. The prohibitions will not apply in respect of:
 - (1) any vehicle being used for the purposes of those works or for fire brigade, ambulance or police purposes;
 - (2) anything done with the permission or at the direction of a police constable in uniform or a person authorised by Transport for London.
- 5. At such times as the prohibitions are in force alternative routes will be indicated by traffic signs. For Bromley Road southbound via Sangley Road, Rushey Green, Brownhill Road, Verdant Lane and Whitefoot Lane to normal route of travel. For Bromley Road northbound via Whitefoot

Lane, Verdant Lane, Brownhill Road, Plassey Road and Sangley Road to
