## ROAD TRAFFIC REGULATION ACT 1984

### THE A205 AND A21 GLA ROADS (CATFORD GYRATORY, LONDON BOROUGH OF LEWISHAM) (TEMPORARY PROHIBITION OF TRAFFIC AND STOPPING) ORDER 2023

1. Transport for London in consultation with the London Borough of Lewisham hereby gives notice that it has made the above named Traffic Order under section 14(1) of the Road Traffic Regulation Act 1984 for the purpose specified in paragraph 2. The effect of the Order is summarised in paragraph 3.
2. The purpose of the Order is to enable drainage investigation works to take place on the A205 Brownhill Road/ Sangley Road/ Catford Road/ Plassy Road/ Rushey Green and A21 Rushey Green/ Bromley Road.
3. The effect of the Order will be to prohibit any vehicle from:
  - (1) entering or proceeding in an easterly direction on Brownhill Road between its junctions with Plassey Road and Bowness Road;
  - (2) stopping on Brownhill Road between its junctions with Plassey Road and Rushey Green;
  - (3) entering, proceeding or stopping on Sangley Road between its junction with the A205 Plassey Road/Sangley Road and No.56 Sangley Road;
  - (4) entering or proceeding in a westerly direction on Sangley Road between its junction with Shorndean Street and No.56 Sangley Road, local access will be maintained;
  - (5) entering or proceeding in a southerly direction on Rushey Green between its junctions with Brownhill Road and Sangley Road;
  - (6) entering or proceeding in a southerly direction on Canadian Avenue between its junction with Catford Road and No.7 Canadian Avenue;
  - (7) stopping on Canadian Avenue between its junctions with Catford Road and No.7 Canadian Avenue;
  - (8) stopping on Rushey Green between its junctions with George Lane and Sangley Road;
  - (9) stopping on Plassey Road between its junctions with Brownhill Road and Sangley Road;
  - (10) stopping on Sangley Road between its junctions with Plassey Road and Rushey Green;
  - (11) stopping on Bromley Road between its junctions with Sangley Road and Culverley Road;
  - (12) stopping on Catford Road between its junctions with Rushey Green and Nelgarde Road;
  - (13) stopping in the loading bay outside No.2 Thomas' Lane.

Works will be phased such that some restrictions will apply only at certain times.

The Order will be effective at certain times between 6th November 2023 and 6th May 2024, every night 10:00 PM until 5:00 AM or when the works have been completed whichever is the sooner. The prohibitions will apply only during such times and to such extent as shall from time to time be indicated by traffic signs.

4. The prohibitions will not apply in respect of:
  - (1) any vehicle being used for the purposes of those works or for fire brigade, ambulance or police purposes;
  - (2) anything done with the permission or at the direction of a police constable in uniform or a person authorised by Transport for London.
5. At such times as the prohibitions are in force alternative routes will be indicated by traffic signs. For A205 eastbound via Plassey Road, Sangley Road, Bromley Road, Bromley Hill, London Road, Tweedy Road, College Road, Burnt Ash Lane and Baring Road to normal route of travel. For Sangley Road eastbound via A205 Sangley Road, Rushey Green, Brownhill Road, Torridon Road and Sandhurst Road to normal route of travel. For Sangley Road westbound via Sandhurst Road, Torrindon Road and Brownhill Road to normal route of travel. For Canadian Avenue, eastbound traffic via Catford Road eastbound, Rushey Green, Brownhill Road, Plassey Road, Sangley Road and Bromley Road to normal route of travel. For Canadian Avenue, westbound traffic via Catford Road westbound, Doggett Road, Bradgate Road, Rushey Green, Brownhill Road, Plassey Road, Sangley Road and Bromley Road to normal route of travel.
