## **ROAD TRAFFIC REGULATION ACT 1984**

THE A3212 GLA ROAD (GROSVENOR ROAD/ MILLBANK, CITY OF WESTMINSTER) (TEMPORARY PROHIBITION OF TRAFFIC AND STOPPING) ORDER 2023

- 1. Transport for London in consultation with the City of Westminster hereby gives notice that it has made the above named Traffic Order under section 14(1) of the Road Traffic Regulation Act 1984 for the purpose specified in paragraph 2. The effect of the Order is summarised in paragraph 3.
- 2. The purpose of the Order is to enable tree/crane works to take place on the A3212 Grosvenor Road/ Millbank.
- 3. The effect of the Order will be to prohibit any vehicle from: (I) entering, exiting, proceeding or stopping on Grosvenor Road
  - between its junctions with Lupus Street and Claverton Street; (2) entering or proceeding in a south-westerly direction on Grosvenor Road between its junctions with Vauxhall Bridge Road and Claverton Street, local access will be maintained;
  - (3) entering or proceeding in an easterly direction on Grosvenor Road between its junctions with Chelsea Bridge and Lupus Street, local access will be maintained:
  - (4) entering or proceeding in a southerly direction on the roundabout at the junctions of Millbank/ Lambeth Bridge and Horseferry Road between Lambeth Bridge eastbound and Lambeth Bridge

(5) suspend the northern footway of Grosvenor Road from a point 40

westbound; The Order will also:

- metres east of No.104 Grosvenor Road (Darwin House) to a point 76 metres eastwards
- (6) permit all vehicles to turn left into Chelsea Bridge Road from Chelsea Embankment:
- (7) permit all vehicles to turn right into Chelsea Bridge Road from Grosvenor Road;
- (8) permit all vehicles to turn left into Bessborough Gardens from Grosvenor Road. Works will be phased such that some restrictions will apply only at

The Order will be effective at certain times between 25th November 2023 and 28th January 2024, every Saturday 7:00 AM until Sunday 5:00 PM or when the works have been completed whichever is the sooner. The prohibitions will apply only during such times and to such extent as

- shall from time to time be indicated by traffic signs. 4. The prohibitions will not apply in respect of:
- (I) any vehicle being used for the purposes of those works or for fire
  - brigade, ambulance or police purposes; (2) anything done with the permission or at the direction of a police
- constable in uniform or a person authorised by Transport for London. 5. At such times as the prohibitions are in force alternative routes will be

indicated by traffic signs. For Grosvenor Road closure via Lupus Street,

Claverton Street, Bessborough Street, Drummond Gate, and Bessborough Gardens or reverse to normal route of travel. For Horseferry Roundabout closure via Lambeth Bridge eastbound,

Roundabout at the junction of Albert Embankment/ Lambeth Road/ Lambeth Bridge and Lambeth Bridge westbound to normal route of
