## **ROAD TRAFFIC REGULATION ACT 1984** THE A200 GLA ROAD (JAMAICA ROAD, LONDON BOROUGH OF

SOUTHWARK) (TEMPORARY PROHIBITION OF TRAFFIC AND STOPPING) ORDER 2023

1. Transport for London in consultation with the London Borough of

Southwark hereby gives notice that it intends to make the above named Traffic Order under section 14(1) of the Road Traffic Regulation Act 1984 for the purpose specified in paragraph 2. The effect of the Order is summarised in paragraph 3. 2. The purpose of the order is to allow works to be undertaken to enhance

- the safety and operation of the cycle way 4 route on the A200 Jamaica Road. 3. The effect of the Order will be to prohibit any vehicle from:
  - entering, exiting or proceeding in an easterly direction on Jamaica
  - Road between its junctions with St James's Road and West Lane;
  - stopping on Jamaica Road between its junctions with Prospect (2) Street and No.74 Jamaica Road;
  - (3)turning right from West Lane into Jamaica Road; entering West Lane at its junction with Jamaica Road;
  - (5) entering, exiting, proceeding or stopping on Southwark Park Road
  - between its junctions with Jamaica Road and New Place Square; (6) entering or proceeding in a northerly direction on Southwark Park Road between its junctions with Clement's Road and New Place
  - Square, local access will be maintained;
  - (7) entering, proceeding or stopping on Abbey Street between its junctions with Jamaica Road and Old Jamaica Road;
  - (8) entering, proceeding or stopping on Marine Street between its
  - junctions with Bowley House and Jamaica Road;
  - entering, proceeding or stopping on Bevington Street between its junctions with Scott Lidgett Crescent and Jamaica Road; (10) entering, proceeding or stopping on St James's Road between its
  - junctions with Jamaica Road and No.22 St James's Road; (11) entering or proceeding in a northerly direction on St James's Road between its junction with Dockley Road and No.22 St James's

The Order will be effective at certain times between 8:00 AM on the

- Road, local access will be maintained; The Order will also:
- (12) suspend the eastbound and westbound bus lanes on Jamaica Road between its junctions with Prospect Street and Abbey Street;
- (13) suspend the cycle track on Tooley Street between its junctions with Queen Elizabeth Street and Jamaica Road.
  - Works will be phased such that some restrictions will apply only at certain times
  - 25th November 2023 and 7:00 PM on the 15th May 2024 or when the works have been completed whichever is the sooner. The prohibitions
  - will apply only during such times and to such extent as shall from time to time be indicated by traffic signs.
- 4. The prohibitions will not apply in respect of:
  - (I) any vehicle being used for the purposes of those works or for fire
    - brigade, ambulance or police purposes;
    - (2) anything done with the permission or at the direction of a police
  - constable in uniform or a person authorised by Transport for London.

5. At such times as the prohibitions are in force alternative routes will be indicated by traffic signs. For Jamaica Road eastbound via St James's Road, Southwark Park Road, Galleywall Road, Rotherhithe New Road, Hawkstone Road and Lower Road to normal route of travel. For Abbey Street via Jamaica Road, Lower Road, Hawkstone Road, Rotherhithe New Road, Raymouth Road, Southwark Park Road, Grange Road and Tower Bridge Road or reverse to normal route of travel. For St James's Road via Jamaica Road, Abbey Road, Bermondsey Street, Grange Road
