ROAD TRAFFIC REGULATION ACT 1984

THE A3220 GLA ROADS (PEMBROKE ROAD AND HOLLAND ROAD, ROYAL BOROUGH OF KENSINGTON AND CHELSEA) (TEMPORARY PROHIBITION OF TRAFFIC AND STOPPING AND **BANNED TURNS) ORDER 2023**

- Transport for London, having consulted with the Royal Borough of Kensington & Chelsea, hereby gives notice that it intends to make the above named Traffic Order under section 14(1) of the Road Traffic Regulation Act 1984 for the purpose specified in paragraph 2. The effect of the Order is summarised in paragraph 3.
- 2. The purpose of the Order is for kerb and footway construction works to take place on A3320 Pembroke Road and A3220 Holland Road.
- 3. The effect of the Order will be to prohibit any vehicle from:
 - entering, exiting or proceeding northbound on Pembroke Villas between its junctions with (1) Pembroke Square and Pembroke Walk; (2)
 - stopping at the eastern kerb-line of Pembroke Gardens between its junction with Pembroke Road and 6m north of the extended southern property boundary of No. 12 Pembroke Gardens:
 - (3) stopping at the western kerb-line of Pembroke Gardens between its junction with Pembroke Road and the extended southern property boundary of No.5 Pembroke Villas; (4) stopping at the eastern kerb-line of Cromwell Crescent between its junction with Pembroke
 - Road and Logan Place; (5)stopping on Earl's Court Road between its junctions with Pembroke Road and Cromwell
 - Road: (6) stopping on Logan Place between its junction with Earl's Court Road and the extended
 - eastern building line of No.15 Logan Place; (7)stopping on West Cromwell Road between its junctions with Warwick Road and Earl's Court
 - (8) stopping in the Loading and Unloading Only Bay outside Nos. 346 – 354 Kensington High
 - Street: turning left from A3220 Pembroke Road into Pembroke Villas;
 - (10) turning left from A3220 Pembroke Road into Earl's Court Road;
 - (11) entering, exiting or proceeding on Earl's Court Road between its junctions with Stratford
 - Road and Lexham Gardens; This restriction does not apply to vehicles exiting Pembroke Road. Local access only will be maintained for southbound traffic between Scarsdale Villas and Stratford Road.
 - (12) turning left from Earl's Court Road into Lexham Gardens; (13) entering, exiting or proceeding westbound on Stratford Road between its junctions with

 - Earl's Court Road and Abingdon Road; Local access will be maintained up to Shaftsbury Mews
 - (14) stopping on Stratford Road between its junctions with Earl's Court Road and Abingdon Road;
 - (15) entering, exiting, proceeding or stopping on Lexham Gardens between its junctions with Earl's Court Road and Lexham Mews;
 - Only one carriageway will be closed at any one time (16) turning left from Earl's Court Road into Cromwell Road;

 - (17) turning right from Cromwell Crescent into Pembroke Road;
 - (18) stopping on Pembroke Road between its junctions with Warwick Road and Earl's Court Road;
 - (19) stopping on Napier Road between its junctions with Holland Road and Napier Place;
 - (20) turning right from A3220 Holland Road into Addison Crescent;
 - (21) stopping on A3220 Holland Road between its junctions with Addison Crescent and Napier Road:
 - (22) entering or exiting Napier Place at its junction with A3220 Holland Road;
 - (23) stopping on A3220 Holland Road between its junctions with Kensington High Street and
 - Addison Crescent;
 - (24) stopping at the south-eastern kerb-line of Holland Gardens between its junction with
 - Holland Road and the extended western building line of No. 83 Holland Road.
 - Works will be phased such that some restrictions will apply only at certain times The Order will be effective from 8:00 AM on 13th November 2023 until 10:00 PM on 7th December 2024 or when the works have been completed whichever is the sooner. The
- prohibition will apply only during such times and to such extent as shall from time to time be indicated by traffic signs. 4. The prohibitions will not apply in respect of:
 - (I) any vehicle being used for the purposes of those works or for fire brigade, ambulance or police
 - purposes; (2) anything done with the permission or at the direction of a police constable in uniform or a
- person authorised by Transport for London. 5. At such times as the prohibition is in force an alternative route will be indicated by traffic signs via:
- [For vehicles travelling to Napier Road] Holland Road, Addison Crescent, Addison Road onto normal route of travel. [For vehicles travelling to Addison Crescent] Holland Park, Holland Park Roundabout, Holland Road onto normal route of travel. [For vehicles travelling eastbound on Pembroke Road] Pembroke Road westbound, Warwick Road, Kensington High Street, Earl's Court Road onto normal route of travel OR Earl's Court Road, West Cromwell Road, Warwick Road, Kensington High Street onto normal route of travel. [For vehicles travelling to Lexham Gardens] Earl's Court Road, Cromwell Road, Marloes Road onto normal route of travel. [For vehicles travelling to Cromwell Road] Kensington High Street, Kensington Road, Queen's Gate, Cromwell Road onto normal route of travel OR Earl's Court Road Southbound, Old Brompton Road, Cromwell Place onto normal route of travel. [For vehicles travelling southbound on Earl's Court Road] Stratford Road, Abingdon Road, Scarsdale Villas, Earl's Court Road northbound, Kensington High

Street, Warwick Gardens, Pembroke Road onto normal route of travel. Dated this 3rd day of November 2023
