ROAD TRAFFIC REGULATION ACT 1984

THE A205 GLA ROAD (THURLOW PARK ROAD AND SIDE ROADS, LONDON BOROUGH OF LAMBETH AND SOUTHWARK) (TEMPORARY PROHIBITION OF TRAFFIC AND STOPPING) ORDER 2023

1. Transport for London in consultation with the London Borough of Lambeth hereby gives notice that it has made the above named Traffic Order under section 14(1) of the Road Traffic Regulation Act 1984 for the purpose specified in paragraph 2. The effect of the Order is summarised in paragraph 3.
2. The purpose of the Order is to enable carriageway resurfacing works to take place on the A205 Thurlow Park Road.
3. The effect of the Order will be to prohibit any vehicle from:
 - (1) entering, exiting, stopping or proceeding on Thurlow Park Road between its junctions with Gallery Road and Thurlow Hill. Local access only will be maintained between Norwood Road and Thurlow Hill and Lordship Lane and Gallery Road;
 - (2) entering, exiting, stopping or proceeding on the northern arm of Croxted Road between its junction with access road to Nos. 38 to Croxted Road and Thurlow park Road;
 - (3) entering, exiting, stopping or proceeding on the southern arm of Croxted Road between its junctions with the northern access road to Spenser Mews and Thurlow Park Road;
 - (4) entering, exiting, stopping or proceeding on Carson Way between its junction with Thurlow Park Road and the southern building line of No. 116 Thurlow Park Road;
 - (5) entering, exiting, stopping or proceeding on the northern arm of Rosendale Road between the extended common boundary of Nos. 4 & 5 Sydcote, No. 161 Rosendale Road and its junction with Thurlow Park Road;
 - (6) entering, exiting, stopping or proceeding on the southern arm of Rosendale Road between its junction with Thurlow Park Road and the extended northern building line of No. 170 Rosendale Road;
 - (7) entering, exiting, stopping or proceeding on Dalmore Road between its junction with Thurlow Park Road and the extended southern building line of No. 82 Thurlow Park Road;
 - (8) entering, exiting, stopping or proceeding on Lancaster Avenue between its junction with Turlow Park Road and Tulesmere Road;
 - (9) entering, exiting, stopping or proceeding on Turlow Park Road between its junction with Norwood Road and Lordship Lane.No vehicular access to Lords Close and Cedar Close will be maintained, provisional parking will be available on all side roads. Works will be phased such that some restrictions will apply only at certain times. The Order will be effective at certain times from 7.00 AM on 27th December 2023 until 6.00 AM on 27th May 2024 or when the works have been completed whichever is the sooner. The prohibitions will apply only during such times and to such extent as shall from time to time be indicated by traffic signs.
4. The prohibitions will not apply in respect of:
 - (1) any vehicle being used for the purposes of those works or for fire brigade, ambulance or police purposes;
 - (2) anything done with the permission or at the direction of a police constable in uniform or a person authorised by Transport for London.
5. At such times as the prohibitions are in force an alternative route will be indicated by traffic signs for **eastbound traffic** via Norwood Road northbound, Herne Hill, Denmark Hill, Champion Park, Grove Lane, Dog Kennel Hill, Grove Vale, Lordship Lane, to normal route of travel and the other way around for **westbound traffic**. **For traffic not wanting to access Thurlow Park Road** via Norwood Road southbound, Norwood High Street, Elder Road, Central Hill, Westow Hill, Crystal Palace Parade, College Road, Dulwich Wood Park, South Croxted Road, Croxted Road and to normal route of travel.
