## The Lewisham (Various Roads, Crofton Park, SE4) (Temporary Prohibition of Traffic) Order 2024 NOTICE IS HEREBY GIVEN that Lewisham Council made the above named

temporary traffic order under the provisions of section 14(1) of the Road Traffic Regulation Act 1984 because of regeneration works on and adjacent to the highway. The effects of the order are indicated below.

- 1. (1) Road closure and no parking/waiting in (i) Brockley Road, between Marnock Road and Dalrymple Road; (ii) Darfield Road, Merritt Road, and Beecroft Road within 50 metres of Brockley Road. (2) The respective diversion routes for traffic affected by the prohibitions are via (i) Brockley Road, Brockley Grove, Ladywell Road, Adelaide Avenue and Brockley Road and vice versa; (ii) Darfield or Merritt Road (as applicable) Brockley Grove, and Brockley Road, and vice versa; (iii) Brockley Road, with Vice versa; (iii) Brockley Road, with Vice versa; (iii) Brockley Road, and vice versa; (iii) Brockley Road, Whitbread Road, Albevorn Road. Dalrymple Road, and Vice versa; (iii) Brockley Road, Whitbread Road, Albevorn Road. Dalrymple Road. and Beecroft Road.
- 2. (1) One way working eastbound and no parking/waiting in Darfield Road and Merritt Road, between Brockley Road and a point 50 metres eastwards thereof. (2) The diversion routes for traffic affected by the probibitions are via Darfield Road or Merritt Road (as applicable) Brockley Grove and Brockley Road.
- Suspension of the one way working in Beecroft Road during closure of Beecroft Road. (Note: Beecroft Road is expected to be closed for one or two nights only to facilitate resurfacing operations).
   Exemption is provided in the Order for vehicles engaged on the works,
- vehicles being used for ambulance, fire brigade or police purposes and anything done with the permission or at the direction of a police officer.

  5. The Order comes into force on 5th February 2024 to remain in force for up to 3 months. (Note: Works are planned to be carried out between
- 15th January and early March 2024, but addition duration has been allowed for contingencies).

  6. The prohibitions and suspensions apply as, when and to the extent
- **6.** The prohibitions and suspensions apply as, when and to the extent signed on the highway.
