- STOPPING) ORDER 2024 1. Transport for London in consultation with the Royal Borough of Greenwich hereby gives notice that it intends to make the above named Traffic Order under section 14(1) of the Road Traffic Regulation Act 1984
- summarised in paragraph 3. 2. The purpose of the Order is to enable highway resurfacing works to take place on the A2213 Kidbrooke Park Road, A20 Sidcup Road/ Eltham

for the purpose specified in paragraph 2. The effect of the Order is

- Road. 3. The effect of the Order will be to prohibit any vehicle from:
- (I) entering, exiting, proceeding or stopping Kidbrooke Park Road
 - between its junctions Weigal Road and Eltham Road; (2)
 - entering or proceeding on Tudway Road between its junction with Kidbrooke Park Road and Ottley Drive;
 - (3)entering or proceeding on Cambert Way between its junction with Kidbrooke Park Road and Gate 1 of Kidbrooke Village; (4)turning right from Sidcup Road into Eltham Road;
 - (5)entering or proceeding in an easterly direction on Eltham Road between its junctions with Burnt Ash Road to Nos. 159 Eltham
 - Road, local access will be maintained; (6) entering or proceeding in an easterly direction on Eltham Road between Nos.159 Eltham Road and its junction with Cedarhurst
 - Drive; entering, exiting, proceeding or stopping on Sidcup Road between (7)its junctions with Eltham Road and Westhorne Avenue;
 - (8) entering or proceeding on Abergeldie Road between its junctions with Scotsdale Road and Sidcup Road, local access will be maintained;

(9) entering or proceeding on Eltham Road westbound between its

- junctions with Yorkshire Grey Roundabout and Crathie Road; (10) stopping Eltham Road between its junctions with Yorkshire Grey
- Roundabout and Sidcup Road; (11) turning right from Kidbrooke Park Road into Eltham Road;
- The Order will also permit all vehicles to use the westbound bound bus lanes on Eltham Road between its junctions with Cedarhurst Drive and
- Works will be phased such that some restrictions will apply only at certain times. The Order will be effective at certain times between 17th January 2024 and 17th July 2024, every night 9:00 PM until 5:00 AM or when the
- works have been completed whichever is the sooner. The prohibitions will apply only during such times and to such extent as shall from time to time be indicated by traffic signs.
- 4. The prohibitions will not apply in respect of: any vehicle being used for the purposes of those works or for fire
- brigade, ambulance or police purposes; anything done with the permission or at the direction of a police constable in uniform or a person authorised by Transport for
- London. 5. At such times as the prohibitions are in force alternative routes will be
 - indicated by traffic signs. For Kidbrooke Park Road closure via Rochester Way, Westhorne Avenue, Yorkshire Grey Roundabout and Eltham Road or reverse to normal route of travel. For Kidbrooke Park Road northbound and Eltham Road eastbound closures via Eltham Road westbound, Lee Road, Lee Bridge, Lewisham High Street, Blackheath Village, Tranquil Vale, Royal Parade, Montpelier Row, Prince Charles Road, Shooters Hill Road and Rochester Way to normal route of travel. For Sidcup Road and Eltham Road westbound closures via Westhorne Avenue, Rochester Way, Shooters Hill Road, Prince of Wales Road, Montpelier Row, Blackheath Village, Lee Road and Eltham Road to
