

# Transport for London Notice

## ROAD TRAFFIC REGULATION ACT 1984

### THE A23 GLA ROAD (BRIGHTON ROAD AND FARTHING WAY, LONDON BOROUGH OF CROYDON) (TEMPORARY PROHIBITION OF TRAFFIC AND STOPPING) ORDER 2024

1. Transport for London hereby gives notice that it intends to make the above-named Traffic Order under section 14(1) of the Road Traffic Regulation Act 1984 for the purpose specified in paragraph 2. The effect of the Order is summarised in paragraph 3.
2. The purpose of the Order is to enable carriageway resurfacing works to take place on the A23 Brighton Road.
3. The effect of the Order will be to prohibit any vehicle from:
  - (1) Entering, exiting, stopping or proceeding on the southbound carriageway of Brighton Road between its junctions with A22 Purley Road and Old Lodge Lane. Local access to be maintained from Old Lodge Lane to Groveland Road.
  - (2) Entering, exiting, stopping or proceeding on the northbound carriageway of Brighton Road/Farthing Way between its junctions with the roundabout at A237 Brighton Road/A23 Farthing Way and A22 Purley Road. Local access to be maintained between Purley Knoll and A22 Purley Road.
- (1) The provisions of article 3 above shall apply only during such Works will be phased such that some restrictions will apply only at certain times.

The Order will be effective from 00:01 on 10th February 2024 until 11:59 PM 10th September 2024 or when the works have been completed whichever is the sooner. The prohibitions will apply only during such times and to such extent as shall from time to time be indicated by traffic signs.
4. The prohibitions will not apply in respect of:
  - (1) any vehicle being used for the purposes of those works or for fire brigade, ambulance or police purposes;
  - (2) anything done with the permission or at the direction of a police constable in uniform or a person authorised by Transport for London.
5. At such times as the prohibitions are in force alternative routes will be indicated by traffic signs via (traffic wishing to access Brighton Road via Purley Road) Purley Road, Godstone Road, Wapses Lodge Roundabout, Godstone Hill, M25 westbound, M23 northbound and A23 to normal route of travel.(traffic accessing Brighton Road via Banstead Road) Foxley Lane, Smitham Bottom Lane and Foxley Lane or the reverse to normal route of travel. (for HGV traffic via Farthing Way) Brighton Road, M23, M25 anticlockwise, A22 Godstone Hill, Caterham By-Pass, Godstone Road and Purley Road or the reverse to normal route of travel. (for Non-HGV traffic via Farthing Way) Marlpit Lane, Brighton Road, Lion Green, Foxley Lane, Russel Hill Road and Brighton Road to normal route of travel.
