## ROAD TRAFFIC REGULATION ACT 1984

### THE A205 GLA ROAD (THURLOW PARK ROAD, LONDON BOROUGH OF LAMBETH) (TEMPORARY PROHIBITION OF TRAFFIC, STOPPING AND BANNED TURNS) ORDER 2024

1. Transport for London in consultation with the London Borough of Lambeth hereby gives notice that it has made the above named Traffic Order under section 14(1) of the Road Traffic Regulation Act 1984 for the purpose specified in paragraph 2. The effect of the Order is summarised in paragraph 3.
2. The purpose of the Order is to enable the repair of a dangerous and defective manhole cover in the carriageway to take place on the A205 Thurlow Park Road.
3. The effect of the Order will be to prohibit any vehicle from:
  - (1) stopping in the Parking & Disabled Persons Vehicles bays on Thurlow Park Road outside Nos. 4-8 Thurlow Park Road, outside Nos. 5-7 Thurlow Park Road and outside Nos. 118-124f Thurlow Park Road;
  - (2) turning right from St Faith's Road into Thurlow Park Road;
  - (3) turning right from Thurlow Park Road into Carson Road;
  - (4) turning left from Croxted Road into Thurlow Park Road;
  - (5) entering, exiting, stopping or proceeding in a westerly direction on Thurlow Park Road between its junctions with Croxted Road and the westerly building line of No 112 Thurlow Park Road;
  - (6) entering, exiting, stopping or proceeding in Carson Road at its junction with Thurlow Park Road.

Works will be phased such that some restrictions will apply only at certain times.

The Order will be effective at certain times between 10:00 PM on 22nd February 2024 until 5:00 AM on 27th February 2024 or when the works have been completed whichever is the sooner. The prohibitions will apply only during such times and to such extent as shall from time to time be indicated by traffic signs.

4. The prohibitions will not apply in respect of:
  - (1) any vehicle being used for the purposes of those works or for fire brigade, ambulance or police purposes;
  - (2) anything done with the permission or at the direction of a police constable in uniform or a person authorised by Transport for London.
5. At such times as the prohibitions are in force an alternative route will be indicated by traffic signs for **traffic wanting to turn right out of St Faith's Road** via Left from St Faith's Road, Thurlow Park Road, Birkbeck Hill, Birkbeck Place and Lovelace Road to normal route of travel. For **local westbound traffic on Thurlow Park Road** via Croxted Road and Norwood Road to normal route of travel or via South Croxted Road, Park Hall Road and Rosendale Road to normal route of travel. For **HGV westbound traffic on Thurlow Park Road** via South Croxted Road, Dulwich Wood Park, College Road, Crystal Palace Parade, Church Road, Beulah Hill, Knights Hill and Norwood Road to normal route of travel.
