ROAD TRAFFIC REGULATION ACT 1984 THE VARIOUS GLA ROADS (LONDON BOROUGHS OF WANDSWORTH, LAMBETH AND MERTON) (TEMPORARY PROHIBITION OF TRAFFIC AND STOPPING) ORDER 2024

- Transport for London hereby gives notice that it has made the above named Traffic Order under section 14(1) of the Road Traffic Regulation Act 1984 for the purpose specified in paragraph 2. The effect of the Order is summarised in paragraph 3.
- The purpose of the Order is to enable highway lining and signage works to take place on the roads listed in Article 3 below in the London Boroughs
- of Wandsworth, Merton and Lambeth. 3. The effect of the Order will be to prohibit any vehicle from:
- (I) entering, exiting or stopping on the A3205 GLA Roads Nine Elms Lane/ Battersea Park Road between its junctions with York Road and Wandsworth Road;
- (2) entering, exiting or stopping on the A3220 GLA Roads - Battersea
- Bridge Road/ Latchmere Road/ Cambridge Road/ Prince of Wales Drive between its junctions with Lavender Hill and Battersea Bridge; entering, exiting or stopping on the A3036 GLA Road – East Hill (3)
- between its junctions with Marcilly Road and Huguenot Place; (4) entering, exiting or stopping on the A3 GLA Road – Woodwell Street/ Wandsworth High Street/ East Hill/ Huguenot Place/ Marcilly Road/
 - North Side Wandsworth Common/ Battersea Rise/ Clapham Common North Side between West Hill and Long Road and on West Hill between Wandsworth High Street and Putney Heath Lane; entering, exiting or stopping on the A205 GLA Road – The Avenue/ (5)
 - Clapham Common West Side between its junctions with Clapham Common South Side and Battersea Rise and on Upper Richmond Road/ Upper Richmond Road West between its junctions with Putney High Street and Priests Bridge: entering, exiting or stopping on the A217 GLA Road – Armoury Way (6)
 - between its junctions with Putney Bridge Road and Swandon Way; entering, exiting or stopping on the A24 GLA Road - London Road/ Crown Lane/ Crown Road between its junctions with Morden Road and No.136 London Road;
 - (8) entering, exiting or stopping on the A297 GLA Road - St Heliers Avenue between its junctions with Morden Hall Road and Rosehill Court Parade:
 - The Order will also permit:
 - all vehicles to use the bus lanes on the A3205 GLA Roads Nine
 - Elms Lane/ Battersea Park Road between its junctions with York Road and Wandsworth Road;

 - (10) all vehicles to use the bus lanes on the A3220 GLA Roads -Battersea Bridge Road/ Latchmere Road/ Cambridge Road/ Prince of Wales Drive between its junctions with Lavender Hill and Battersea Bridge;
 - (11) all vehicles to use the bus lanes on the A3036 GLA Road East Hill between its junctions with Marcilly Road and Huguenot Place; (12) all vehicles to use the bus lanes on the A3 GLA Road – Woodwell Street/ Wandsworth High Street/ East Hill/ Huguenot Place/ Marcilly Road/ North Side Wandsworth Common/ Battersea Rise/ Clapham Common North Side between West Hill and Long Road and on West Hill between Wandsworth High Street and Putney Heath Lane;

(13) all vehicles to use the bus lanes on the A205 GLA Road – The Avenue/ Clapham Common West Side between its junctions with

- Clapham Common South Side and Battersea Rise and on Upper Richmond Road/ Upper Richmond Road West between its junctions with Putney High Street and Priests Bridge; (14) all vehicles to use the bus lanes on the $\widetilde{A217}$ GLA Road – Armoury Way between its junctions with Putney Bridge Road and Swandon Way;
- (15) all vehicles to use the bus lanes on the A24 GLA Road London Road/Crown Lane/ Crown Road between its junctions with Morden Road and No.136 London Road;
- (16) all vehicles to use the bus lanes on the A297 GLA Road St Heliers Avenue between its junctions with Morden Hall Road and Rosehill Court Parade.

Works will be phased such that some restrictions will apply only at certain

- times. The Order will be effective at certain times from 12:01 AM on 5th February 2024 until 5:00 AM on 5th August 2024 or when the works have been completed whichever is the sooner. The prohibitions will apply only
- during such times and to such extent as shall from time to time be indicated by traffic signs. The prohibitions will not apply in respect of:
- 4. (I) any vehicle being used for the purposes of those works or for fire brigade, ambulance or police purposes;
- (2) anything done with the permission or at the direction of a police constable in uniform or a person authorised by Transport for London.
- At such times as the prohibitions are in force alternative routes will be indicated by traffic signs.
