## **ROAD TRAFFIC REGULATION ACT 1984 - SECTION 14**

## TEMPORARY TRAFFIC AND PARKING RESTRICTIONS - SHAKESPEARE ROAD

- 1. NOTICE IS GIVEN that to facilitate Thames Water mains replacement, the Council of the
- London Borough of Lambeth made an Order the effect of which will be to introduce a phased temporarily ban on vehicles from entering Shakespeare Road and the suspension of parking places on Shakespeare Road, Railton Road and Dulwich Road between:-
- Phase 1 11 March 2024 to 25 March 2024
  - Road closure and parking bays suspended on Shakespeare Road from the junction of Dulwich Road to outside No. 31 Shakespeare Road;
  - Parking bays suspended on (a) Shakespeare Road from the junction of Dulwich Road to outside No. 31 Shakespeare Road, and (b) on Dulwich Road outside Nos. 19 to 35, 39 to 53, and 34 to 48 Dulwich Road.
- Phase 2 25 March 2024 to 15 April 2024
  - Road closure of Shakespeare Road from No. 31 Shakespeare Road to the junction of Railton Road. Parking bays suspended on both sides of Shakespeare Road from No. 31
  - Shakespeare Road to the junction of Railton Road.
- Phase 3 15 April 2024 to 6 May 2024
  - Road closure of Shakespeare Road between the junctions of Railton Road and Mayall Road.
  - Parking bays suspended on Shakespeare Road, both sides between (a) the junctions of Railton Road and Mayall Road, (b) from outside No.59 Shakespeare Road to the iunction of Railton Road, and (c) Railton Road, both sides, between the junctions of Spenser Road and Milton Road.
- Phase 4 6 May 2024 to 27 May 2024
  - Parking bays suspended on (a) Shakespeare Road, both sides from outside No.59 Shakespeare Road to the junction of Railton Road, (b) Shakespeare Road, both sides,
  - between the junctions of Railton Road and Mayall Road, (c) Railton Road, both sides, between the junctions of Spenser Road and Milton Road.
- Phase 5 27 May 2024 to 10 June 2024
  - Road closure and parking bays suspended on Shakespeare Road between the iunctions of Railton Road and Mavall Road.
- 2. Alternative routes for affected vehicles will be available for phase 1 & 2 via (a) Dulwich Road, Milton Road, Railton Road, and (b) Railton Road, Spenser Road, Dulwich Road and phase 3 via (c) Railton Road, Mayall Road, and (d) Railton Road, Chaucer Road, Mayall Road
- 3. The ban will only apply at such times and to such extent as shall be indicated by the
- placing of the appropriate traffic signs. 4. The Order comes into force on 11 March 2024 and continues for a maximum duration of 12 months (to allow for contingencies) or until the works have been completed whichever is the sooner. In practice, it is anticipated that the works will take place in phases indicated in paragraph 1, but if the works cannot be carried out or completed during that time then the Order may have effect at subsequent times within the maximum period of
