

# Transport for London Notice

## ROAD TRAFFIC REGULATION ACT 1984

### THE A24 GLA ROAD (TOOTING HIGH STREET, LONDON BOROUGH OF WANDSWORTH) (TEMPORARY PROHIBITION OF TRAFFIC AND STOPPING) ORDER 2024

1. Transport for London hereby gives notice that it has made the above named Traffic Order under section 14(1) of the Road Traffic Regulation Act 1984 for the purpose specified in paragraph 2. The effect of the Order is summarised in paragraph 3.
2. The purpose of the Order is to enable carriageway resurfacing works to take place on the A24 Tooting High Street.
3. The effect of the Order will be to prohibit any vehicle from:
  - (1) entering, proceeding, exiting or stopping on Garratt Lane between the extended common boundary of Nos. 1071 and 1073 Garratt Lane and its junction with Tooting High Street;
  - (2) entering, proceeding, exiting or stopping on Tooting High Street between its junction with Garratt Terrace and the extended north-eastern building line of Nos. 57 and 59 Tooting High Street;
  - (3) entering, proceeding, exiting or stopping on Mitcham Road from the extended common boundary of Nos. 22 and 24 Mitcham Road and its junction with Tooting High Street; Gatemanned access and egress will be maintained for all closures.

Local access only will be maintained for closure (1) from between its junction with Fountain Lane and extended common boundary of Nos. 1071 and 1073 Garratt Lane.

Local access only will be maintained for closure (2) from between its junctions with Priory Road and Garratt Terrace and from its junction with Tooting Bec Road and the extended north-eastern building line of Nos. 57 and 59 Tooting High Street.

Local access only will be maintained for closure (3) from between its junction with Southcroft Road and the extended common boundary of Nos. 22 and 24 Mitcham Road.

The Order will be effective from 10:00 PM to 5:00 AM every night from the 25th March 2024 to 25th April 2024 or until the works has been completed. The prohibitions will apply only during such times and to such extent as shall from time to time be indicated by traffic signs.

4. The prohibitions will not apply in respect of:
  - (1) any vehicle being used for the purposes of those works or for fire brigade, ambulance or police purposes;
  - (2) anything done with the permission or at the direction of a police constable in uniform or a person authorised by Transport for London.
5. At such times as the prohibitions are in force alternative routes will be indicated by traffic signs via: [For Tooting High Street] Tooting Bec Road, Ambleside Avenue, Mitcham Lane, Streatham Road, London Road, Holborn Way, Upper Green West, Raleigh Gardens, Western Road, Priory Road and reverse to normal route of travel. [For Garratt Lane] Blackshaw Road, Fountain Road to normal route of travel. [For Mitcham Road] Tooting Bec Road, Rectory Road, Mitcham Road to normal route of travel.
