ROAD TRAFFIC REGULATION ACT 1984

THE A23 GLA ROAD (BRIXTON HILL AND SIDE ROADS, LONDON BOROUGH OF LAMBETH) (TEMPORARY PROHIBITION OF TRAFFIC, STOPPING AND SUSPENSION OF BUS LANE) ORDER 2024

1. Transport for London in consultation with the London Borough of Lambeth hereby gives notice that it has made the above named Traffic Order under section 14(1) of the Road Traffic Regulation Act 1984 for the purpose specified in paragraph 2. The effect of the Order is summarised in paragraph 3.
2. The purpose of the Order is to enable construction of a new pedestrian crossing to take place on the A23 Brixton Hill.
3. The effect of the Order will be to prohibit any vehicle from:
 - (1) stopping on Brixton Hill between its junctions with Trent Road/Brixton Water Lane and Fairmount Road;
 - (2) entering, exiting or proceeding in a easterly direction on Trent Road between its junction with Brixton Hill and a point opposite the extended common boundary of Nos. 17 and 19 Trent Road;
 - (3) entering, exiting or proceeding in a westerly direction on Brixton Water Lane between its junction with Brixton Hill and the westernmost building line of No. 8 Mannering House, Brixton Water Lane;
 - (4) entering, exiting or proceeding in a easterly direction on Lambert Road between its junction with Brixton Hill and a point 2.5 metres east of the extended western building line of No.78 Brixton Hill;
 - (5) exiting on Josephine Avenue at its junction with Brixton Hill. Except for pedal cycles proceeding eastwards;
 - (6) entering, exiting or proceeding on St Saviour's Road between its junction with Brixton Hill and extended common boundary of Nos. 2 and 4 St Saviour's Road;
 - (7) entering, exiting or proceeding on Arodene Road between its junctions with Brixton Hill and Hermes Court;
 - (8) entering, exiting or proceeding in a easterly direction on Blenheim Gardens between its junction with Brixton Hill and westernmost building line boundary of No. 112D Brixton Hill;
 - (9) entering, exiting or proceeding in a westerly direction on Fairmont Road from a point 35 metres north-west of the extended north westernmost building line of Nos. 5 Raleigh Gardens, Brixton Hill;
 - (10) stopping on Trent Road between its junctions with Brixton Hill and Horsford Road;
 - (11) stopping on St Saviour's Road between its junctions with Brixton Hill and Halliwell Road;
 - (12) stopping on Arodene Road between its junctions with Brixton Hill and Helix Gardens;
 - (13) stopping on Blenheim Gardens between its junctions with Brixton Hill and Halliwell Road;
 - (14) stopping on Fairmont Road between its junctions with Brixton Hill and Beechdale Road;

The Order will also:

- (15) close the south-western bound bus lane on Brixton Hill between its junctions with Brixton Water Lane and Arodene Road;
- (16) close the north-eastern bound bus lane on Brixton Hill between the south-westernmost building line of No. 118 Brixton Hill and the north-easternmost building line of No. 94 Brixton Hill;
- (17) permit all vehicles to use all bus lanes on Brixton Hill between its junctions with Blenheim Gardens and Lambert Road.

Works will be phased such that some restrictions will apply only at certain times.

The Order will be effective between 8:00 AM on 6th June 2024 until 6:00 PM on 7th August 2024, or when the works have been completed whichever is the sooner. The prohibition will apply only during such times and to such extent as shall from time to time be indicated by traffic signs. Both Carriageways will not be used simultaneously.

4. The prohibitions will not apply in respect of:
 - (1) any vehicle being used for the purposes of those works or for fire brigade, ambulance or police purposes;
 - (2) anything done with the permission or at the direction of a police constable in uniform or a person authorised by Transport for London.

At such times as the prohibition is in force an alternative route will be indicated by traffic signs for eastbound traffic wanting Josephine Avenue via Brixton Water Lane to normal route of travel. Or for westbound traffic wanting Brixton Hill from Josephine Avenue via Effa Road and St Matthew's Road to normal route of travel. For eastbound traffic wanting Arodene Road via Brixton Hill, Elm Park, Leander Road and Helix Road to normal route of travel. Or for westbound traffic wanting Brixton Hill from Arodene Road via Helix Gardens, Effa Road and St Matthew's Road to normal route of travel. For westbound traffic wanting St Saviours Road via Blenheim Gardens and Halliwell Road to normal route of travel. Or via Lambert Road to normal route of travel. For eastbound traffic wanting Brixton Hill from St Saviour's Road via Lambert Road, Bonham Road and Hayter Road to normal route of travel.
