ROAD TRAFFIC REGULATION ACT 1984

THE A402 GLA ROAD (PARK LANE, CITY OF WESTMINSTER) (TEMPORARY PROHIBITION OF TRAFFIC, STOPPING AND BUS LANE SUSPENSION AND BANNED TURNS) ORDER 2024

1. Transport for London in Consultation with the City of Westminster hereby gives notice that it intends to make the above named Traffic Order under section 14(1) of the Road Traffic Regulation Act 1984 for the purpose specified in paragraph. The effect of the Order is summarised in paragraph 3.
2. The purpose of the Order is to enable signal modification works to take place at A402 Park Lane.
3. The effect of the Order will be to prohibit any vehicle from:
 - (1) turning right into Brook Gate from the western arm of Park Lane;
 - (2) turning right into Curzon Gate from the eastern arm of Park Lane;
 - (3) turning right into Stanhope Gate from the western arm of Park Lane;
 - (4) turning right from the western arm of Park Lane into unnamed road connecting the north-western carriageway of Park Lane with south-eastern carriageway of Park Lane;
 - (5) entering Deanery Street at its junction with Park Lane;
 - (6) exiting Stanhope Gate at its junction with Park Lane;
 - (7) stopping on both sides of Park Lane between its junctions with Marble Arch and Hyde Park Corner.

The Order will also prohibit any pedal cycle from:

- (1) proceeding in the cycle way on Park Lane from its junctions between South Carriage Drive and North Carriage Drive;
- (2) proceeding in the cycle way connecting the eastern arm of Park Lane and the western arm of Park Lane.

This Order will also permit all vehicles to use all Bus Lanes on both sides of Park Lane between its junctions with Marble Arch and Hyde Park Corner.

The Order will be effective at certain times from 8.00 AM on the 22nd June 2024 until 11.59 PM on the 30th August 2025 or when the works have been completed whichever is the sooner. The prohibition will apply only during such times and to such extent as shall from time to time be indicated by traffic signs.

Works will be phased such that some restrictions will apply only at certain times.

4. The prohibitions will not apply in respect of:
 - (1) any vehicle being used for the purposes of those works or for fire brigade, ambulance or police purposes;
 - (2) anything done with the permission or at the direction of a police constable in uniform or a person authorised by Transport for London.
5. At such times as the prohibition is in force an alternative route will be indicated by traffic signs via for vehicles travelling from Park Lane northbound via Cumberland Gate, Marble Arch, Park Lane to normal route of travel. for vehicles traveling from Park Lane southbound via Park Lane, Achilles Way, Park Lane to normal route of travel. for vehicles travelling from Curzon Gate/ Stanhope gate via Park Lane, Brook Gate, Park Lane to normal route of travel. for vehicles travelling from Stanhope Gate/Curzon Street via Park Lane (northbound) Deanery Street, Tilney Street, Audley Street, Mount Street, Park Lane to normal route of travel. (southbound) Park Lane, Brook Gate, Park Lane to normal route of travel. for vehicles travelling from Park Lane/Deanery Street via Curzon Street, South Audley Street, Stanhope Gate to normal route of travel.
