ROAD TRAFFIC REGULATION ACT 1984

THE A23 GLA ROAD (VARIOUS ROAD, LONDON BOROUGH OF CROYDON) (TEMPORARY PROHIBITION OF TRAFFIC AND STOPPING) ORDER 2024

1. Transport for London in consultation with the London Borough of Croydon hereby gives notice that it intends to make the above named Traffic Order under section 14(1) of the Road Traffic Regulation Act 1984 for the purpose specified in paragraph 2. The effect of the Order is summarised in paragraph 3.
2. The purpose of the Order is to enable drainage investigation works to take place on the A23 Purley Way, Foxley Lane, Banstead Road.
3. The effect of the Order will be to prohibit any vehicle from:
 - (1) entering Banstead Road at its junction with Brighton Road, local access will be maintained for Banstead Road;
 - (2) stopping on Russell Hill Road between its junctions with Foxley Lane and Brighton Road;
 - (3) stopping on Foxley Lane between its junctions with Banstead Road and Russell Hill Road;
 - (4) proceeding from Foxley Lane into Pampisford Road;
 - (5) entering or proceeding in a south-easterly direction on Pampisford Road between its junctions with Christchurch Road and Purley Way, local access will be maintained between Christchurch Road and No.22 Pampisford Road;
 - (6) stopping in the Loading bay outside Nos.1 to 19 The Exchange, Purley Road;
 - (7) stopping on Whytecliffe Road South between its junctions with Station Approach and Purley Way;
 - (8) turning left from Highfield Road into Purley Way;
 - (9) turning left from Purley Way into Highfield Road.

Works will be phased such that some restrictions will apply only at certain times.

The Order will be effective at certain times between 24 th June 2024 and 24 th December 2024, every night 9:00 PM until 5:00 AM or when the works have been completed whichever is the sooner. The prohibitions will apply only during such times and to such extent as shall from time to time be indicated by traffic signs.

4. The prohibitions will not apply in respect of:
 - (1) any vehicle being used for the purposes of those works or for fire brigade, ambulance or police purposes;
 - (2) anything done with the permission or at the direction of a police constable in uniform or a person authorised by Transport for London.
5. At such times as the prohibitions are in force alternative routes will be indicated by traffic signs. For Banstead Closure via Brighton Road, Warham Road, Denning Avenue, Stafford Road, Sandy Lane South, Foresters Drive, Plough Lane and Foxley Lane to normal route of travel. For Pampisford Road/ Foxley Lane closure via Purley Way and Waddon Way to normal route of travel. For Pampisford Road southbound closure via Christchurch Road, Brighton Road, Banstead Road and Foxley Lane to normal route of travel. For Highfield banned left via Edgehill Road, Pampisford Road and Waddon Way to normal route of travel. For Highfield closure via Purley Way, Waddon Way and Pampisford Road to normal route of travel.
