ROAD TRAFFIC REGULATION ACT 1984

THE A22 GLA ROAD AND SIDE ROADS (GODSTONE ROAD AND SIDE ROADS, LONDON BOROUGH OF CROYDON) (TEMPORARY PROHIBITION OF TRAFFIC AND STOPPING) ORDER 2024

1. Transport for London in consultation with the London Borough of Croydon hereby gives notice that it has made the above named Traffic Order under section 14(1) of the Road Traffic Regulation Act 1984 for the purpose specified in paragraph 2. The effect of the Order is summarised in paragraph 3.
2. The purpose of the Order is to enable lighting works to take place on the A22 Godstone Road.
3. The effect of the Order will be to prohibit any vehicle from:
 - (1) entering, exiting, stopping or proceeding on the access road fronting Nos. 33 to 75 Godstone Road (northern arm), Kenley between its junction with Godstone Road and the extended common boundary of Nos. 49 and 51 Godstone Road, Kenley;
 - (2) stopping on Dale Road (northern arm) between its junction with Godstone Road and the access road to Lister Court, Godstone Road;
 - (3) stopping on Dale Road (southern arm) between its junction with Godstone Road and the extended common boundary of No. 72 Godstone Road and No. 39 Dale Road;
 - (4) stopping on Sunnysdene Road between its junction with Godstone Road and the north-eastern building line of No. 2a Sunnysdene Road;
 - (5) stopping on Silverdale Road between its junction with Godstone Road and the south-western building line of Church Hall, Kenley Methodist Church, Silverdale Road;
 - (6) stopping on Lower Road between its junction with Godstone Road and the extended south-eastern building line of No.2 Lower Road;
 - (7) stopping on Little Roke Road between its junctions with Godstone Road and Lower Road/Roke Close;
 - (8) stopping on Hayes Lane between its junctions with Godstone Road and Station Road;
 - (9) stopping on Waterbourne Way between its junction with Godstone Road and the south-western property boundary of Nos. 1 to 14 Kendal Court, Godstone Road, Kenley;
 - (10) stopping on Bourne View between its junctions with Godstone Road and Gomshell Gardens;
 - (11) stopping on Bourne Park Close between its junction with Godstone Road and the south-western property boundary of No. 324 Godstone Road, Kenley;
 - (12) stopping on Devon Close between its junction with Godstone Road and the extended common boundary of Nos. 8 and 9 Devon Close;

- (13) stopping on the north-eastern kerb-line of Godstone Road between the north-western building line of No. 1 Bridge Parade, Godstone Road and the south-eastern building line of No. 251 Godstone Road, Kenley;
- (14) stopping on the south-western kerb-line of Godstone Road between the north-western building line of No. 1 Bridge Parade, Godstone Road and the extended common boundary of Nos. 400 and 402 Godstone Road, Kenley;

This Order will also:

- (15) close the pedestrian crossing on Godstone Road outside the Garage, No. 14-16 Godstone Road;
- (16) close the pedestrian crossing on Godstone Road at its junction with St James Road;
- (17) close the pedestrian crossing on Godstone Road outside Nos.7 - 8 Valley View Gardens and No. 38 Garston Lane;
- (18) close the pedestrian crossing on Godstone Road outside Birchwood Court, Nos. 167 to 169 Godstone Road, Kenley;
- (19) close the footway between Godstone Road and Approach Road. Marshals will be on hand whilst the works are taking place to aid pedestrians when required.

Local access to Famet Gardens, Valley View Gardens and Harris Primary Academy will be maintained.

Works will be phased such that some restrictions will apply only at certain times.

The Order will be effective at certain times between 8:00 AM on 15th July 2024 until 4:30 PM on 15th January 2025 or when the works have been completed whichever is the sooner. The prohibitions will apply only during such times and to such extent as shall from time to time be indicated by traffic signs.

4. The prohibitions will not apply in respect of:
 - (1) any vehicle being used for the purposes of those works or for fire brigade, ambulance or police purposes;
 - (2) anything done with the permission or at the direction of a police constable in uniform or a person authorised by Transport for London.
5. At such times as the prohibitions are in force alternative pedestrian routes will be indicated by traffic signs.
