ROAD TRAFFIC REGULATION ACT 1984

THE A2213 GLA ROAD (KIDBROOKE PARK ROAD AND A20 GLA ROAD (ELTHAM ROAD/ SIDCUP ROAD, ROYAL BOROUGH OF GREENWICH (TEMPORARY PROHIBITION OF TRAFFIC AND STOPPING) ORDER 2024

1. Transport for London in consultation with the Royal Borough of Greenwich hereby gives notice that it intends to make the above named Traffic Order under section 14(1) of the Road Traffic Regulation Act 1984 for the purpose specified in paragraph 2. The effect of the Order is summarised in paragraph 3.
2. The purpose of the Order is to enable carriageway lining works to take place on the A2213 Kidbrooke Park Road and A20 Sidcup Road/ Eltham Road.
3. The effect of the Order will be to prohibit any vehicle from:
 - (1) entering, exiting, proceeding or stopping on Kidbrooke Park Road between its junctions with Tudway Road and Eltham Road;
 - (2) entering, exiting or proceeding in a southerly direction on Kidbrooke Park Road between its junctions with Henley Cross and Tudway Road. Local access to be maintained between Tudway Road and Henley Cross;
 - (3) entering, exiting, proceeding or stopping on Sidcup Road between its junctions with Eltham Road and Westthorne Avenue. Both carriageways will not be closed simultaneously;
 - (4) stopping on the north-western side of Westthorne Avenue between its junction with Sidcup Road and the common boundary of Nos.407-409 Westthorne Avenue;
 - (5) turning right from Crathie Road into Eltham Road;
 - (6) entering, exiting, proceeding or stopping on Abergeldie Road between its junctions with Sidcup Road and Scotsdale Road. Local access to be maintained between Sidcup Road and Scotsdale Road;

Works will be phased such that some restrictions will apply only at certain times.

The Order will be effective between 27th July 2024 and 27th January 2025, every night 9:00 PM until 5:00 AM or when the works have been completed whichever is the sooner. The prohibitions will apply only during such times and to such extent as shall from time to time be indicated by traffic signs.

4. The prohibitions will not apply in respect of:
 - (1) any vehicle being used for the purposes of those works or for fire brigade, ambulance or police purposes;
 - (2) anything done with the permission or at the direction of a police constable in uniform or a person authorised by Transport for London.
5. At such times as the prohibitions are in force alternative routes will be indicated by traffic signs. For access to Sidcup Road via Abergeldie Road (Horn Park Lane, Westthorne Avenue, Eltham Road and Sidcup Road to normal route of travel). For access to Kidbrooke Park Road via Eltham Road (Eltham Road and Weigall Road to normal route of travel) To access Eltham Road via Kidbrooke Park Road (Weigall Road and Eltham Road to normal route of travel). For southbound Kidbrooke Closure (Kidbrooke Park Road, A2 Off-Slip, U-Turn Sun in the Sands Roundabout, On Slip, A2, Off-Slip, A205 South Circular Road and Eltham Road to normal Route of travel). For eastbound traffic accessing Kidbrooke Park Road (Eltham Road, Yorkshire Grey, South Circular Road, A2, A2 Off-slip Road to normal route of travel). For northbound closures via Rochester Way), Kidbrooke Park Way, Rochester Way off-slip Sun-in-the-sands roundabout, Rochester Way Relief Road and Westthorne Avenue to normal route of travel.
