## **ROAD TRAFFIC REGULATION ACT 1984**

THE A23 GLA ROAD AND SIDE ROADS (BRIXTON ROAD, ATLANTIC ROAD AND FERNDALE ROAD, LONDON BOROUGH OF LAMBETH) (TEMPORARY PROHIBITION OF TRAFFIC AND STOPPING) ORDER 2024

- 1. Transport for London in consultation with London Borough of Lambeth hereby gives notice that it intends to make the above named Traffic Order under section 14(1) of the Road Traffic Regulation Act 1984 for the purpose specified in paragraph 2. The effect of the Order is summarised in paragraph 3.
- 2. The purpose of the Order is to enable traffic signal upgrade works and
- associated resurfacing works to take place on the A23 Brixton Road. 3. The effect of the Order will be to prohibit any vehicle from:

(I) entering, exiting or proceeding on Atlantic Road between its

- junctions with Brixton Road and Electric Lane; (2) entering, exiting, stopping or proceeding on Ferndale Road between
- its junctions with Brixton Road and Stockwell Avenue; (3) stopping on Brixton Road between its junctions with Electric Avenue
- and Stockwell Road; (4) stopping on Atlantic Road in the loading bays outside Arch No. 11 Atlantic Road to Arch No. 15 Atlantic Road:

The Order will also:

- (5) permit all vehicles to use all bus lanes on the A23 Brixton Road between its junctions with Gresham Road and Electric Avenue: (6) suspend the one-way operation on Ferndale Road, permitting two-
- way operation for local traffic between its junctions with Brixton Road and Nursery Road. Works will be phased such that some restrictions will apply only at

August 2024 until 8:00 AM on 16th October 2024, or when the works have been completed whichever is the sooner. The prohibition will apply only during such times and to such extent as shall from time to time be indicated by traffic signs. 4. The prohibitions will not apply in respect of:

The Order will be effective at certain times between 8:00 AM on 5th

- (I) any vehicle being used for the purposes of those works or for fire
  - brigade, ambulance or police purposes; (2) anything done with the permission or at the direction of a police
  - constable in uniform or a person authorised by Transport for London.
- 5. At such times as the prohibitions are in force an alternative route will be indicated by traffic signs for eastbound traffic wanting Atlantic Road via Brixton Road and Coldharbour Lane to normal route of travel. For westbound traffic wanting Atlantic Road via Coldharbour Lane, Effra Lane, St Matthew's Road and Brixton Hill to normal route of travel. For traffic wanting Ferndale Road via Brixton Road, Stockwell Road, Chantry

Road, Dalvell Road and Pulross Road to normal route of travel.
