THE A3220 GLA ROAD (REDCLIFFE GARDENS, ROYAL BOROUGH OF KENSINGTON & DELSEA) (TEMPORARY PROHIBITION OF TRAFFIC AND STOPPING) ORDER 2024

- Transport for London hereby gives notice that it has made the above named Traffic Order under section 14(1) of the Road Traffic Regulation Act 1984 for the purpose specified in paragraph 2. The effect of the Order is summarised in paragraph 3.
- 2. The purpose of the Order is to enable junction improvement works to take place on A3220 Redcliffe Gardens.

 3. The effect of the Order will be to prohibit any vehicle from:
 - stopping on A3220 Redcliffe Gardens between its junctions with Old Brompton Road and Fawcett Street;
 entering, exiting, proceeding or stopping on Redcliffe Square at its
 - junctions with A3220 Redcliffe Gardens;
 - (3) entering, exiting, proceeding or stopping on Tregunther Road at its junctions with A3220 Redcliffe Gardens;
 (4) entering, exiting, proceeding or stopping on Fawcett Street at its
 - junctions with A3220 Redcliffe Gardens;
 (5) entering A3220 Redcliffe Gardens southbound at its junction with
 - Old Brompton Road;
 (6) entering, exiting, proceeding or stopping on A3220 Redcliffe
 Gardens between its junction with Redcliffe Street and No. 47
 - Redcliffe Gardens;
 (7) entering, exiting, proceeding or stopping on A3220 Redcliffe

Gardens between its junction with Cathcart Road and No. 17

Redcliffe Gardens
This Order will also allow:

- (8) two way operations on Fawcett Street at both sides of Redcliffe Gardens;
- (9) two way operations on Redcliffe Gardens between its junctions with Cathcart Road and Tregunter Road

Works will be phased as such that not all restrictions may apply at any one time. Local access will be maintained.

The Order will be effective at certain times from 8:00 AM on 1 st November 2024 until 6:00 PM on 30 th November 2025 or when the works have been completed whichever is the sooner. The prohibition will apply only during such times and to such extent as shall from time to time be indicated by traffic signs.

- 4. The prohibitions will not apply in respect of:
 - (I) any vehicle being used for the purposes of those works or for fire brigade, ambulance or police purposes;
 - (2) anything done with the permission or at the direction of a police constable in uniform or a person authorised by Transport for London.
- 5. At such times as the prohibition is in force an alternative route will be indicated by traffic signs via [For Redcliffe Square closure] Redcliffe Gardens, Redcliffe Street, Westgate Terrace to normal route of travel OR Redcliffe Tregunter Road, Harcourt Terrace to normal route of travel. [For Tregunter Road closure] Redcliffe Gardens, Fawcett Street, Hollywood Street to normal route of travel. [For Fawcett Street closure] Redcliffe Gardens, Redcliffe Place, Finborough Road to normal route of travel OR Redcliffe Gardens, Fulham Road, Hollywood Road to
