

# **LONDON BOROUGH OF LEWISHAM**

## **Road Traffic Regulation Act 1984**

### **The Lewisham (Various Roads – Hither Green, SE13)**

#### **(Temporary Prohibition of Traffic) Order 2023**

**NOTICE IS HEREBY GIVEN** that Lewisham Council made the above named temporary traffic order under the provisions of section 14(1) of the Road Traffic Regulation Act 1984 because of works at Hither Green Station on and adjacent to the highway. The effects of the order are indicated below.

**1.** (1) Road closure and no parking/waiting in (i) Fernbrook Road, between the projected western boundary of No.18 Fernbrook Road and the projected common boundary between Nos.68 & 68A Fernbrook Road. (ii) Springbank Road, between the projected common boundary of Nos.26 & 28 Springbank Road and the projected common boundary of Nos.56 & 58 Springbank Road; (iii) Brightside Road, between Springbank Road and the projected common boundary of Nos. 11 and 13 Brightside Road; and (iv) Elthruda Road, between Springbank Road and the projected common boundary of Nos. 64 and 66 Elthruda Road.

(2) The diversion routes for traffic affected by the prohibitions are via (i) Leahurst Road, Staplehurst Road and Fernbrook Road and vice versa; (ii) Duncricvie Road, Hither Green Lane, Beacon Road, Nightingale Grove and Springbank Road; (iii) Springbank Road, Nightingale Grove, Ennersdale Road, Hither Green Lane, Duncricvie Road and Springbank Road. (iii) Brightside Road, Hither Green Lane, Duncricvie Road and Springbank Road; and (iv) Elthruda Road, Hither Green Lane, Duncricvie Road and Springbank Road.

(Note: Waiting restrictions will be in force for much of the duration of the Order to facilitate the works but full road closures are planned only as follows: - (i) Springbank Road 2nd Jan to 5th April 2024 (ii) Fernbrook Road 4th March to 30th June 2024. There will however be occasional weekend closures throughout the duration of the Order and information will be provided in advance to residents at the relevant locations. Please note all dates are liable to change).

**2.** Prohibitions relating to the Fire Gate in Nightingale Grove between Brightside Road and Ardmere Road are suspended during the closure of Springbank Road.

**3.** Exemption is provided in the order for vehicles engaged on the works, vehicles being used for ambulance, fire brigade or police purposes and anything done with the permission or at the direction of a police officer.

**4.** The order comes into force on 1st October 2023 to remain in force for up to 18 months.

**5.** The prohibitions will apply as, when and to the extent signed on the highway.
