NOTICE regarding Street Trading Fees and Charges

NOTICE IS HEREBY GIVEN as required by Section 32(7)(b) of the London Local Authorities Acts 1990 to 2007 that the Mayor and Burgesses of the London Borough of Lambeth (hereinafter referred to as "the Council") propose to vary the fees and charges paid to them by street trading licence holders. Section 32 of the London Local Authorities Act 1990 enables us to recover our such charges as may be sufficient in the aggregate taking one year with another to cover the reasonable costs, not otherwise recovered, of:

- (a) the collection, removal and disposal of refuse or other services rendered by them to such holders;
- (b) the cleansing of streets in which street trading takes place in so far as that cleansing is attributable to such trading;
- (c) any reasonable administrative or other costs incurred in connection with the administration of this Part of the Act; and
- (d) the cost of enforcing the provisions of Part 3 of the Act.
