1. The Council of the London Borough of Lewisham proposes to make the above Traffic Regulation Orders under Sections 6, 32, 35, 36, 45, 46 and 49 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 (as amended) the effect of which is to:- (a) carry out amendments to the Blackheath Controlled Parking

specified therein; (e) provide shared use permit holders and pay by phone parking places in the lengths of roads specified in Schedule 3 to this Notice, for use by vehicles for which the appropriate charge is paid or valid permit holders for the appropriate zone within the operational days and hours specified therein; (f) provide parking places for electric vehicle charging in the length of road specified in Schedule 4 to this Notice for use for electric vehicles to which the relevant charge is paid in respect to that vehicle and that any electric

vehicle is being charged at all times while it is left in the parking place; (g) introduce a cycle hangar (secure cycle parking facilities for hire) in Schedule 5 and Schedule 8 to this Notice; (h) revoke the restrictions in Schedule 6 to this Notice without replacement. Where a new restriction has been proposed in the same length of road, the existing restrictions will be replaced 2 by those proposed restrictions.
